## **Pranic Healing Foundation Mauritius**

### **Guidelines to set up a Centre in Mauritius**

#### **Requirements to open a Centre.**

The requirements to open a Centre are given below. It is divided into general and specific requirements. The general or common requirements apply to both PHC and PHAYC

A Pranic Healing Centre (PHC) refers to a 'small' Centre in terms of capacity and conducts Pranic healing sessions, courses and Meditation on Twin Hearts.

A Pranic Healing and Arhatic Yoga Centre (PHAYC) refers to a 'large' Centre in terms of capacity and is allowed to conduct AY activities such as AY meditations, retreats and practices in addition to the activities that a PHC can offer.

More details are provided under the section 'Specific requirements' below.

- A. General (or common requirements) to set up either a Pranic Healing Centre (PHC) or a Pranic Healing and Arhatic Yoga Centre (PHAYC):
- 1. Attended Arhatic Yoga Preparatory Level, Kriya Shakti and Pranic Feng Shui courses.
- 2. Be One-Pointed in Spreading GMCKS' teachings, courses, books, and CDs.
- 3. Offer Pranic Healing and Arhatic Yoga modalities only. No other healing modalities will be offered.
- 4. Practice the 5 Pillars of GMCKS' Arhatic Yoga
- 5. Is already an ACPH or has enrolled for ACPH course.
- 6. Has executed previous Pranic Healing and Arhatic Yoga projects.
- 7. The proposed centre should be at <u>least 5 kms</u> away from the nearest existing centre, unless mutually agree taking into account population density.
- 8. Academic and Professional qualification (optional)
- B. Specific requirements regarding Pranic Healing Centre (PHC) and Pranic Healing and Arhatic Yoga Centre (PHAYC):
- 9. Capacity, Infrastructure of the centre and other specific requirements are given below:
